

The following are the rules (“**Rules**”) for the **Leavens Volkswagen Go-Kart** giveaway (the “**Giveaway**”) being administered by Leavens Volkswagen (“**LVW**”).

1. ELIGIBILITY

To be eligible for the Giveaway, entrants must be legal residents of Ontario, be of the age of majority or older at the time of entry in their province or territory of residence and have a valid Facebook account. Employees of **LVW** and its affiliates, subsidiaries, related companies, advertising and promotional agencies and the household members of any of the above, are not eligible to participate in the Giveaway.

2. HOW TO ENTER

NO PURCHASE NECESSARY. To enter, entrants must like and comment on a Leavens Volkswagen post with an appropriate answer to the giveaway question as determined by a **LVW** representative. The Giveaway shall run from **Saturday July 18, 2020 9:00 a.m.** to **Wednesday, August 19 2020 11:59 p.m.** (the “**Giveaway Period**”) after which time no further entries will be considered.

3. SELECTION OF WINNER

Upon completion of the Giveaway, a **LVW** representative shall **review the answers submitted and determine which entrants provided the correct answer**. In the unlikely event that more than one post containing the correct answer is received, a **LVW** representative shall conduct a random draw from the entrants who have tied. The potential winner will be contacted by private Facebook message and will have forty-eight hours to respond and provide their contact information. If a selected potential winner does not respond in the allotted time, another potential winner may be selected at **LVW**'s sole discretion.

4. PRIZE[S]

There is **one** Prize available to be won, each of which consists of **a complete detail package for their vehicle**. The approximate value of the prize is three hundred dollars (CDN\$300). The Prize **is** not transferable and not redeemable for cash, will not be extended under any circumstances and must be accepted as offered without substitution.

5. RELEASE
